#### **Preamble**

This Rector's order regulates the Internal Competition Announcement of the Grant Agency of Gregor Johann Mendel of Mendel University in Brno (hereinafter referred to as the "Agency"). The support provider is Mendel University in Brno (hereinafter referred to as the "University"). The projects are the University internal projects and are governed by the Rector's Guideline No. 4/2023, Grant Agency of Gregor Johann Mendel of Mendel University in Brno, and the Rector's Methodological Instructions for individual support categories.

### Article 1 Basic provisions

- (1) The Rector announces a competition on 1 April 2023 to support Agency projects under the category C—Return Projects.
- (2) The administration of project proposals is carried out in the verso3.mendelu.cz system, Project, and Contract Register (hereinafter referred to as the "PCR System").
- (3) The Research and Development (R&D) department is the relevant workplace responsible for the Agency's administration.
- (4) The individual support categories are regulated by the Rector's Methodological Instructions for the respective calls.

### Article 2 Competition objective

The main aim of the grant support **under the category C—Return Projects** is to enable scientists to return to a full-fledged scientific career at the University, to support their further development and achieve outstanding scientific results in the long term. One of the conditions for a successful scientific career is the harmonisation of work and family life, especially during the period when workers care for children under the age of 6. The support for the successful applicant includes the assignment of an individual talent manager under the care of the Human Resources Management Department, who will support the researcher in professional and personal development.

### Article 4 Application process

Project proposals and applications for support shall be submitted exclusively through the PCR System. Subsequently, the application form, including the required attachments, must be generated from the PCR System, printed, and signed by the proposer and delivered to the office of the Research and Development (R&D) at any time during the competition period. The PCR system is not only used for the application submission but also for the needs of the grant evaluation process. The login details are the same as for the UIS university information system.

### Article 5 Competition conditions

All key conditions of the internal competition of the Agency are specified in the relevant Rector's Guideline No. 4/2023, Grant Agency of Gregor Johann Mendel of Mendel University in Brno, and the Rector's Methodological Instruction for individual project categories. All the competition documents are available on the Research and Development (R&D) website.

### Article 6 Final provisions

This Rector's Order shall enter into force on the date of its promulgation and shall take effect on the fifth day after its entry into force.
